➤ The Organization for Economic Cooperation and Development (OECD) recently aligned its standards with the Five Freedoms for Animals as encompassed in the World Organization for Animal Health's definition of animal welfare.

Without political will, standards remain a mere spouting of empty words.

In December 2023, the United Nations General Assembly itself called for urgency to ensure that animal health and welfare can contribute to the Sustainable Development Goals, and to the One Health approach (Resolution A/RES/78/168). In addition, the United Nations Environment Programme's Faith for Earth Coalition, launched *Al Mizan: A Covenant for the Earth* at the UN Environment Assembly in February 2024. This important Islamic covenant for the earth, speaks of all created beings having rights, and of mercy to all beings.
